Digital Divide

- American Community Survey: Approx. 3 million Texas households do not have access to broadband.
- Barriers:
 - Lack of infrastructure
 - Digital literacy
 - Affordability and access to devices



House Bill 5 (87R)

- Created the Broadband Development Office (BDO) at the Texas Comptroller of Public Accounts.
- Required the BDO to:
 - Create a state broadband plan (June 2022).
 - Create a broadband development map (January 2023).
 - Implement a broadband development program to administer broadband expansion grants.
 - Serve as an information clearinghouse for state & federal funding opportunities in Texas.
- Created the BDO Board of Advisors
 - Chaired by the Comptroller with seven appointed members by the Governor, Lieutenant Governor, & Speaker



American Rescue Plan Act (ARPA)

- Coronavirus Capital Projects Fund (CPF)
- Administered by U.S. Department of the Treasury
- Texas' Allocation: \$500.5 Million
- Purpose: helping to ensure that all communities have access to the high-quality modern infrastructure, including broadband, needed to access critical services.
- Funds must be expended by Dec. 2026.

Bringing Online Opportunities to Texas (BOOT) Program

- ARPA/CPF funded last mile infrastructure grant program that connects businesses and households to the internet.
- Eligible applicants include political subdivisions, broadband service providers, and partnerships between the two.
- Projects must:
 - Bring at least 100/20 Mbps to locations.
 - Participate in Affordable Connectivity Program (ACP).
 - [Program possibly running out of funding April 2024.](#)
 - Provide a universally available low-cost option.



BOOT Program Next Steps

- March 6 – BOOT Notice of Funding Availability published
- April 3 through May 5 – Applications accepted
- July 21 through Aug. 21 – Application Challenge Period
- Next Steps:
 - Evaluations and awards
 - BOOT Round 2



Broadband Infrastructure Fund (BIF)

Proposition 8 was passed by voters on Nov. 7, 2023.

- The constitutional amendment created the BIF in the Texas Constitution.
- The fund will be financed through money allocated by the state legislature, gifts, grants and investment earnings.
- The purpose of the fund is to enhance the availability and usage of broadband and telecommunications services.
- The fund takes effect on Jan. 1, 2024, and expires on Sept. 1, 2035.
- House Bill (HB) 9 appropriates \$1.5 billion to BIF.



Broadband Infrastructure Fund (BIF)

The Next Generation 9-1-1 Service Fund will receive support from the BIF.

- HB 9 provides for a one-time transfer of \$155,200,000.
- Funds will be transferred no later than September 2024.
- Once transferred, the funds will be managed by the Commission on State Emergency Communications.



Broadband Infrastructure Fund (BIF)

The BIF also supports the Texas Pole Replacement Program.

- Established by HB 1505 in 2021.
- \$75 million in funds were committed with the passage of HB 9
- Funds must be made available to the program by Sept. 15, 2024.



Broadband Infrastructure Fund (BIF)

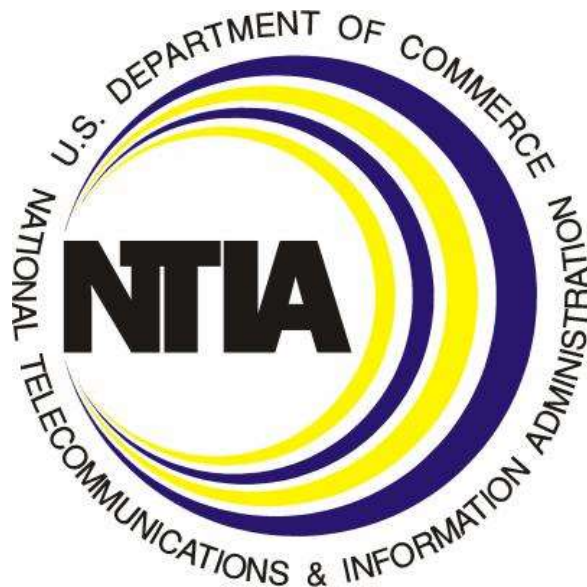
Pole Replacement Program

- Aims to speed up rural broadband deployment by reimbursing a portion of eligible pole replacement costs.
- Reimbursements per pole range from 50% of eligible costs to \$5k (whichever is less).
- Eligible participants are pole owners or qualifying broadband service providers who have incurred eligible pole replacement costs.
- The BDO is currently researching and fact-finding to develop the program.
- More details provided in early 2024.



Infrastructure Investment and Jobs Act (IIJA) Funding

- Administered by the National Telecommunications and Information Administration (NTIA).
 - Broadband Equity, Access, and Deployment (BEAD) Program.
 - Help close the availability gap.
 - Texas's Allocation: \$3.3 billion.
 - Fiber Preference.
 - Digital Equity Act.
 - Help close the digital opportunity gap
 - Expected Allocation: \$130 million.





IIJA Planning Activities and Next Steps

- Public engagement.
- Working Groups.
- Summer 2023 – BDO public meeting tour wrapped up.
- Aug. 31, 2023 – public surveys closed.
- Over 10,000 responses.
- Key dates:
 - Aug. 28: BEAD Five Year Action Plan submitted.
 - Dec. 23: BEAD Initial Proposal submitted.
 - Feb. 28: Texas Digital Opportunity Plan is due.



IIJA BEAD Eligibility

- Eligible locations:
 - Unserved – less than 25/3 Mbps.
 - Underserved – between 25/3 Mbps and 100/20 Mbps.
 - Community Anchor Institutions.
 - [FCC Broadband Map](#).
- Eligible applicants:
 - Internet service providers.
 - Political subdivisions.
 - Nonprofit organizations.
 - Partnerships amongst any of the groups mentioned above.
